## Transportation Networks Start to Strain Under Gov't Shutdown

As the government shutdown stretches into its fourth week, the strain is beginning to show on the nation's transportation systems. Essential government functions underpinning air travel, Amtrak services, and public transit operations are continuing to take place. However, the absence of federal funding and delayed paychecks for workers are beginning to create ripple effects that compromise efficiency, safety, and reliability.

#### **Amtrak Operations**

As Rail Passengers reported before the shutdown began, Amtrak is able to operate with more autonomy than agencies like the Federal Aviation Administration (FAA) due to its diversified sources of revenue—including ticket fares and payments from partner state governments. However, the protracted shutdown at the Federal Railroad Administration will likely result in delays to long-term infrastructure projects and state-of-good-repair work.

On a long enough timeline, the absence of federal operating assistance will result in a disruption to Amtrak service. If the shutdown extends well into November, Rail Passengers expects to hear Amtrak leadership sound the alarm bells about the holiday travel season.

One bit of cold comfort for passengers: a number of other critical government services will have collapsed before we get to the point where Amtrak needs to cancel trains, and so strong incentives exist for Congress to strike a deal before then.

#### **Public Transit Operations**

Public transit systems are operated by local or state governments, but—like highways—rely on the distribution of federal funds for capital projects and operational support. As with Amtrak, operations will continue uninterrupted, but projects awaiting disbursements may face bureaucratic hurdles, slowing down procurement and construction timelines.

Air travel is among the most visibly impacted sectors during a government shutdown. Most FAA and Transportation Security Administration (TSA) employees are categorized as "essential", meaning they must work without pay. This includes air traffic controllers, safety inspectors, and airport screeners.

As the shutdown drags on, we can expect morale among these workers to decline, leading to increased absenteeism and slower operations.

The White House has sent Transportation Secretary Sean Duffy on a public relations tour to warn that air traffic controllers are seeking alternative income sources due to missed paychecks, which could result in staffing shortages and widespread flight delays.

"I can't guarantee that your flight is going to be on time," said Sec. Duffy this week at a Capitol press conference with House Republican leadership. "I can't guarantee that your flight's not going to be canceled. It's going to depend on our air traffic controllers coming in to work every single day,"

# **Airos Head Northeast for Commissioning Tests**

When you win a battle to secure investment funding and it takes years for

that money to get spent, it can make you forget what you won. But this week, less than two months after watching Next Gen Acelas take to the rails in the Northeast Corridor for their first revenue service, <a href="Amtrak's new Airomade its way to the Northeast Corridor for operational testing">Amtrak's new Airomade its way to the Northeast Corridor for operational testing</a> – a real milestone on the way to carrying its first paying passengers on the West Coast next year.

All of our hard work and advocacy and investment is beginning to be tangible, with real trains coming online that you can see, hear, and touch. As Amtrak President Roger Harris told attendees at our RailNation: San Antonio event earlier this month, "This is the first time in decades that Americans can see their [rail] tax dollars at work."

The first Airo trainset left the <u>Federal Railroad Administration's</u> <u>Transportation Technology Center test track in Pueblo, Colo., earlier this week</u> after months of safety and engineering certification tests, passing through Chicago – <u>and Chicago's new car wash!</u> – on Thursday on its way to complete several more months of operational tests along the Northeast Corridor.

Amtrak will base the Airo test train at Philadelphia's Penn Coach Yard facility (itself also getting a huge infrastructure investment) during this test phase, and later it will be joined by a second Airo train to complete commissioning testing before entry into service early next year on the *Cascades* service in the Pacific Northwest between Eugene, Ore., and Vancouver, B.C.

#### **Council Elections**

We are now accepting candidates wishing to be elected to the Council as State Representatives for the two-year term ending February 29, 2028.

The application submission deadline is 11:59 PM Eastern time on Monday, December 1, 2025.

With the State Representative elections coming up, it's more important than ever to be sure your membership shows that you are paid and in good standing. The Candidate Certification Committee will use the final membership roster as of November 30, 2025, as the guide to eligibility. If you were due to renew in September and haven't yet gotten around to it, or your membership is due to expire in October or November, please be sure to get that renewal in place in time for you to be counted on November 30th. Postal Service delays could extend the time it takes for your renewal to reach our offices, so please act as soon as you can. We encourage you to renew online using a credit or debit card or bank account, but if you plan to mail a check, we recommend that you mail it to the office address (1200 G St. NW, Ste 520, Washington, DC 20005). Make sure that you indicate that this is a renewal of your dues and not a donation.

Any Rail Passengers Association member who meets the qualifications may apply for a State Representative seat on the Council of Representatives. Before applying, it is highly recommended that you review these position responsibilities and qualifications:




#### **Getting Started**

Once you're logged in, you'll see your account dashboard. Click "Update Your Info."




Making Updates


